

RESOLUTION NO. 2013-12

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CLEWISTON, FLORIDA, ADOPTING AMENDMENTS TO THE BUDGET FOR FISCAL YEAR 2013-2014; AND, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Clewiston, Florida, must adopt amendments to the budget for the fiscal year 2013-2014, and

WHEREAS, it is necessary that revenues and appropriations be made for said fiscal year as shown by the following budget amendment summarized here and attached and made a part hereof:

GENERAL FUND 001

- Amendment 1) Establish Budget for E. Byrne JAG grant award number
2014-JAGC-HEND-1-E5-012 “Update Mobile Data Units for
Officers in the Field”
from 10/1/2013 through 09/30/2014 . \$ 23,520**
- Amendment 2) Establish Budget for Donation to Golf Course from Couse Farms, Inc.
specifically to purchase rakes. \$ 1,000**

GRANT FUND 120

- Amendment 3) Establish Budget for SW Florida Community Development Grant for
the first of a three year Library Cooperative “I-Help” program.
from 10/1/2013 through 09/30/2014 . \$ 50,000**
- Amendment 4) Establish Budget for State Div. of Cultural Affairs Grant for a
performance by Chris Kayl.
from 09/1/2013 through 05/31/2014. \$ 600**

WHEREAS, Section 166.241(2), Florida Statutes requires that appropriations for said fiscal year be made for all expenditures and that appropriations not exceed revenues; and

WHEREAS, Section 166.241(4)(c), Florida Statutes requires that the budget amendment must be adopted in the same manner as the original budget unless otherwise specified in the municipality's charter; and

WHEREAS, Section 166.241(5), Florida Statutes requires that "If the governing body of a municipality amends the budget pursuant to paragraph (4)C, the adopted amendment must be posted on the official website of the municipality within 5 days after adoption".

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CLEWISTON, FLORIDA:

Section 1. The amendments as summarized above and attached and made part hereof are hereby adopted for the Fiscal Year 2013-2014, effective October 1, 2013.

Section 2. This Resolution and the attached amendments are to be posted on the city's website Clewiston-fl.gov within five (5) days after adoption.
