**RESOLUTION NO. 2024-074**

**A RESOLUTION OF THE CITY OF CLEWISTON,  
FLORIDA, DECLARING A STATE OF LOCAL  
EMERGENCY FOR THE CITY PURSUANT TO SECTION  
252, FLORIDA STATUTES.**

**WHEREAS**, this Special Meeting has been convened in response to the request of the City Manager to declare a State of Emergency; and

**WHEREAS**, the City Commission has heard evidence relating to emergency conditions being caused or threatened by Hurricane Milton; and

**WHEREAS**, on October 5, 2024, the Governor of Florida entered Executive Order No. 24-214 declaring a state of emergency for the State of Florida and entered Executive Order No. 24-215 on October 6, 2024 amending Executive Order No. 24-214; and

**WHEREAS**, on October 6, 2024, Hendry County officials declared a state of emergency for Hendry County;

**WHEREAS**, the City Commission has determined that the conditions may result in substantial injury or harm to the population of the City of Clewiston, and/or may cause substantial property damage and loss within the City of Clewiston.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE  
CITY OF CLEWISTON, FLORIDA, THAT:**

- 1.** A State of Local Emergency is hereby declared for the City of Clewiston, Florida at \_\_\_\_\_ on October 7, 2024, until such time as the State of Emergency is terminated by the City Commission.
- 2.** The City Manager is hereby authorized to take such actions as are necessary to utilize the City of Clewiston resources to protect and provide aid for the people and property of the City.
